This Product offers the Investor a Coupon Rate regardless of the performance of the Underlying during the lifetime. Otherwise the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption".

In addition, the Product can be early redeemed if the relevant conditions are met on any of the Autocall Observation Dates.
